## Advancing Education.

To advance education by providing scholarships, bursaries, and other financial assistance to underprivileged youth and young adults in and from developing countries

To advance education by offering mentorship programs to the youth and young adults in and from developing countries.

To Advance education by providing awards to the youth and young adults to encourage academic excellence

To Advance education by training Human Rights Defenders in developing countries to access knowledge to better support people in their communities.

To advance education by providing books, equipment, and education aids to students attending secondary and post-secondary education in and from developing countries.

To advance education by providing classes on Human Rights and Mental health to the youth, young adults and human rights defenders in developing nations.

To advance education by offering programs and workshops on non-violent communication and conflict resolution for youth and young adults in developing countries.

To advance education by providing scholarships in vocational training and skill development programs for youth and young adults in developing countries and Canada, focusing on trades, technology, and entrepreneurship.

# **Relieving Poverty in developing nations.**

To relieve poverty in developing nations by providing food and other basic necessities of life to individuals or families in need.

To relieve poverty in developing nations by providing basic necessities of life, including food, clean water, clothing, and shelter to individuals and families experiencing poverty and low income.

To relieve poverty in developing nations by providing business and social enterprise start-up grants.

To relieve poverty by providing business and social entrepreneurship coaching and resources to equip individuals and families with the skills and knowledge to establish and sustain their businesses or social enterprises.

To relieve poverty by organizing and participating in international exchanges and volunteer programs that allow Canadians to contribute to development projects in developing countries.

To relieve poverty by providing grants and financial assistance to youth and young adults in developing countries to start small businesses or enterprises.

# **Promoting Human Rights.**

Collaborating with organizations within and outside Canada to deliver mental health support services to address beneficiaries' unique challenges.

To promote mental health awareness and provide mental health services for youth and young adults in developing countries, including counselling, support groups, and educational workshops.

To promote human rights by advocating for the rights and well-being of youth and young adults in developing countries, including the right to education, health, and economic opportunities.

To provide legal assistance and support to youth and young adults in developing countries who are victims of human rights violations.

## **Governance and Transparency**

To conduct research and publish reports on issues affecting youth and young adults in developing countries, including poverty, education, health care, mental health, and human rights.

To collaborate with local and international partners to implement and support initiatives that align with the organization's purposes.

To engage in public awareness campaigns in Canada and abroad to educate the public on issues affecting youth and young adults in developing countries.

To collaborate with local and international partners to implement and support initiatives that align with the organization's purposes.

To solicit, receive, and manage funds to carry out the activities and initiatives that align with the organization's charitable goals.

#### **Promoting Research**

Collaborate with medical scientists/ researchers to involve the youth and young adults in beneficial, ethical medical research by educating youth and young adults on the importance to participate in the research studies.

To collaborate with health authorities in developing countries to conduct research and publish reports on health issues affecting youth and young adults.

To promote mental health awareness in developing countries through educational programs, public awareness campaigns and youth workshops for youth and young adults.

To support the training and skilling of youth mental health counsellors in developing countries by sponsoring them for short counselling courses and workshops.

To promote sexual and reproductive health among youth and young adults in developing countries by teaching them about safe sexual practices.

To collaborate with local and international sexual and reproductive health care providers in developing countries to implement sexual and reproductive health programs among youth and young adults.
